Move In: Tuesday 12:00-4:00 PM(August 27th, 2019), Wednesday 9:00 AM to 4:00 PM (August 28th, 2019). This will be confirmed closer to show date. (There is no preview party this year).

Due to Insurance and safety, an adult MUST be in your booth at all times: while setting up, all show hours, and takedown. No children under 16, at any me, during set-up or take-down, in the hall or loading docks. You and your staff release San Diego Quilt Show, Inc. and its members from any and all claims resulting from damage, injury, or loss to person (including death), and from loss or damage to property, or merchandise in any way connected to the Vendor's use of space and the facilities (San Diego Convention Center) at the 2019 San Diego Quilt Show.

The first 10x10 booth ordered will come with 1 table and 2 chairs. For larger booths number of tables/chairs are per contract that San Diego Quilt Show signs with GES, exhibition services. The exhibition service (GES) will contact you regarding extra tables, chairs, Wi-Fi, electrical, etc. All vendors must come through the loading docks on the backside of the San Diego Convention Center as close to their dock times as possible. Transport from the docks to your booth is done by GES (exhibition service), it is required unless directed otherwise by GES. Permission must be granted for dock space at any me from the Vendor Chair or GES ONLY. Unless permission is given by GES or the Vendor Chair you will be cited and towed at your expense.

SDQS must have a valid California seller's ID (BOE 410) on file for each vendor before booth setup and to participate in the show. Resellers forms are available on our website. Or contact www.boe.ca.gov or call 1-800-400-7115 for info. Vendors also cannot set up if not paid in full. Vendors are responsible to go on the San Diego Convention Center website and adhere to all rules, regulations and responsibilities set forth by the convention center.

Refunds: There are no refunds. If unavailable to vend the funds "may be" applied toward future shows.

Vendors: May not sublet or share their space with another vendor. Each Business must have their own space and a seller's permit or copy of a current BOE form on file with the San Diego Quilt Show Vendor Chair.
